A journey through the 2025 PSSA Conference: Evolve – Enhancing Healthcare Integration

From 7–9 August 2025, the Indaba Hotel and Conference Centre in Johannesburg became the heartbeat of pharmacy in South Africa. Under the theme "Evolve – Enhancing Healthcare Integration", pharmacists, academics, regulators, policymakers, and industry leaders gathered to share ideas, challenge perspectives, and imagine a bold future for pharmacy and healthcare.

Day 1 – Opening the Conversation

The conference began with a warm welcome from Ms Refiloe Mogale. The energy in the room was one of optimism and determination, amplified when Minister of Health, Dr Aaron Motsoaledi, took the podium. He emphasised that health is a fundamental human right and underscored the central role of National Health Insurance (NHI) in achieving equity. Importantly, he reminded the profession that pharmacists are not merely custodians of medicines but architects of a stronger, more equitable health system; key players in making NHI a reality.

The day unfolded with thought-provoking discussions. In "Evolving Health Systems", delegates explored what it truly means to integrate pharmacy into the broader healthcare fabric. The excitement grew as technology took centre stage in "AI and Pharmacy," where experts demonstrated how artificial intelligence could revolutionise everything from prescribing to patient engagement. The day closed on a powerful note with Adv. Sello Malete, who reminded pharmacists of their responsibility in ensuring compliance, ethics, and community trust.

Day 2 - Shaping the Future

The second day was alive with conversations about the expanding scope of pharmacy practice. From chronic disease management to new models of care, speakers highlighted how pharmacists are stepping forward to fill crucial gaps in the health system.

Regulatory updates from SAPC, SAHPRA, and the National Department of Health kept delegates grounded in the realities of compliance and governance, while sessions on TB, diabetes, oncology, and family planning showcased pharmacy's growing role in specialised care.

An energising highlight came from IQVIA's sponsored session, where data-driven insights revealed how self-care and chronic care services can be expanded in practical, patient-focused ways. Delegates left buzzing with ideas of how to make these insights a reality in their own settings.

Day 3 - Reflecting, Celebrating, Inspiring

The final day carried a spirit of reflection and celebration. In the session on pandemic preparedness, pharmacists revisited hard-learned lessons from COVID-19, committing to being better prepared for the next public health crisis.

Then came one of the most inspiring highlights of the conference — "Walk in My Heels". Women leaders from across the profession shared their journeys in advocacy, oncology, nuclear pharmacy, and medico-legal practice. Their stories were raw, powerful, and a reminder of the resilience and brilliance within the profession.

The energy carried through to Cipla's session by Gundo Nevhutanda, an accomplished attorney, titled "Own Your Story", where pharmacists were encouraged to embrace authenticity and

self-leadership. And finally, Dr Stavros Nicolaou (Aspen) lifted the conversation to a global stage, reminding us that South Africa's pharmacists are not only part of the national health system, but also contributors to a wider, interconnected pharmaceutical world.

The conference closed with a renewed sense of unity as PSSA President, Mr Tshifhiwa Rabali, thanked delegates and called on pharmacists to continue evolving for the sake of patients and communities.

The PSSA/Alpha Pharm distance learning programme continues to offer pharmacists useful, practical, up-to-date information that enables them to provide optimal pharmaceutical care to their patients.

Module 4, 2025 – Headache

Most people will have experienced a headache at some stage in their life and up to one adult in 20 experiences frequent headaches (a headache every day or nearly every day). Although headaches are rarely caused by a serious condition, they can significantly interfere with the ability to work and perform daily tasks.

When headaches occur repeatedly, they could be a symptom of a headache disorder. The most common headache disorder is tension-type headache. Migraine is another common headache disorder, affecting at least one in seven adults. Headache disorders can cause substantial personal suffering, affecting family life, social life and employment. Despite this, many people perceive headaches as a trivial complaint and the physical, emotional, social and economic burdens of headaches are poorly acknowledged. According to the World Health Organization (WHO), headache has been underestimated, under-recognised and under-treated throughout the world.

The community pharmacist is in the ideal position to play a role in the management of headache and to refer patients appropriately for further medical attention, if needed. This module discusses headache and the most common types of headache disorders that the community pharmacist is likely to encounter.

The PSSA/Alpha Pharm clinical education programme 2025 for pharmacy staff

The PSSA/Alpha Pharm pharmacy staff clinical education programme continues to offer front-shop assistants or pharmacists' assistants up-to-date information that enables them to provide optimal pharmaceutical care to their patients. All pharmacy staff need to be familiar with the use of unscheduled medicines and should be reminded of when it is necessary to refer the patient to the pharmacist.

Module 4, 2025 – Headache

Headache is one of the most common medical complaints. Nearly everyone will have a headache from time to time. Although most headaches are not caused by life-threatening illnesses, headaches are painful and cause personal suffering. When headaches occur often, they can affect family life, social life and employment.

Despite this, many people – including many health professionals – tend to think of a headache as a minor complaint. Yet, according to the World Health Organization (WHO), headache has been under-estimated, under-recognised, and under-treated all over the world.

The front shop staff are in an ideal position to talk about headache and its treatment when customers present in the pharmacy looking for a medication to relieve their headache quickly. Headache, particularly migraine, can also affect children and adolescents, but symptoms can be different, and it is best to refer children presenting in the pharmacy with a headache to a doctor.

This module talks about the most common headaches in adults that can be treated with medicines available over-the-counter in the pharmacy. The module also outlines the questions that you, as the front shop member of staff, need to ask so that patients with headaches that could be more serious can be referred to the pharmacist and/or doctor.
