### A step in the right direction – Key takeaway from the 8th Business meeting

An improved interest in the YPG Steering Committee was apparent, compared to the previous business meeting (7th Annual Business Meeting). We saw an increase in the number of young pharmacists willing to serve in the YPG. This was reflected by 11 nominations received for the steering committee, with all positions being contested and some being contested by three candidates. We also saw an increase in the number of voters, which more than doubled – from 39 valid votes in 2024 to 91 valid votes in 2025.
